The Minnesota State Board of Investment (SBI) develops and implements investment policies and strategies for the state's retirement funds, trust funds, and cash accounts. As of June 30, 2023, the SBI was responsible for the management of assets totaling just under \$135 billion.

The SBI Summer Intern Program will provide students with broad asset class exposure while they work on various projects across the organization. You will get relevant support and training that will make an impact at the SBI and, ultimately, to its stakeholders. This program is an opportunity to build upon your professional network of mentors and be introduced to investment professionals in the financial community. Students will have increased knowledge of the SBI's mission and function along with resume-building experience.

Program Description:

Students will rotate amongst the public and private markets teams and gain exposure to other areas of the organization throughout the internship. This includes ESG and Stewardship, Legal and Policy, Performance and Analytics, and the Participant Directed Investment Program. Areas where the student will focus their time are with the following:

Investment Teams	Sub-Asset Group
Public Equity	Domestic, International, and Global Equity
Public Fixed Income	Core/Core+ Bonds, Return Seeking Fixed Income, Treasuries, and Laddered Bonds + Cash
Private Markets	Equity, Credit, Real Assets, and Real Estate private funds

Responsibilities:

- Attend meetings with investment management firm.
- Update and create new reports and analyses for the team.
- Assist with the completion of monthly / quarterly / annual internal and external reporting.
- Work with team to update materials in the data management system.
- Gather data, track and report on various portfolio metrics.
- Draft and complete ad-hoc assignments as determined by the team's needs and requirements at that time.
- Participate in broader SBI 2024 Summer Analyst Program projects.

Minimum Qualifications:

- Anticipated graduation date must be between December 2024 and June 2025.
- Have a strong work ethic, personal and professional integrity, and be able to adapt to new encounters in a dynamic environment while handling multiple projects.
- Be able to work individually and to collaborate in a team environment, remaining detail-oriented and client-focused.
- Communications and human relations sufficient to interact with supervisory staff, co-workers, and the public.
- Understand and follow instructions, both oral and written, to complete assignments correctly.

Student must be currently enrolled in a higher education institution and actively pursuing an undergraduate or graduate degree. If you are enrolled at a credit-granting institution, you must carry at least six semester credits; if enrolled at a non-credit granting institution or one that only offers one credit per class, you must be taking two or more classes per semester. You will be asked to complete an Educational Verification form prior to appointment.

- Students majoring in non-investment related fields of study are also encouraged to apply.
