New Private Markets Commitments for Consideration

At the November 13, 2023 Investment Advisory Council (IAC) meeting, the IAC concurred with SBI Staff's recommendation to the private markets fund commitments listed below.

These commitments will be presented to the State Board of Investment at its November 29, 2023 meeting for approval.

All private markets investment commitments are subject to the amounts listed below or (in the case of commingled funds) a maximum of 20% of the fund - whichever is less. Each of the items below is subject to final negotiations between the firm and the SBI.

Until the Executive Director on behalf of the SBI executes a formal agreement, further due diligence and negotiations may result in the imposition of additional terms and conditions on the General Partner or reduction or termination of the commitment.
